Residential 2: Roxburgh Bungalow

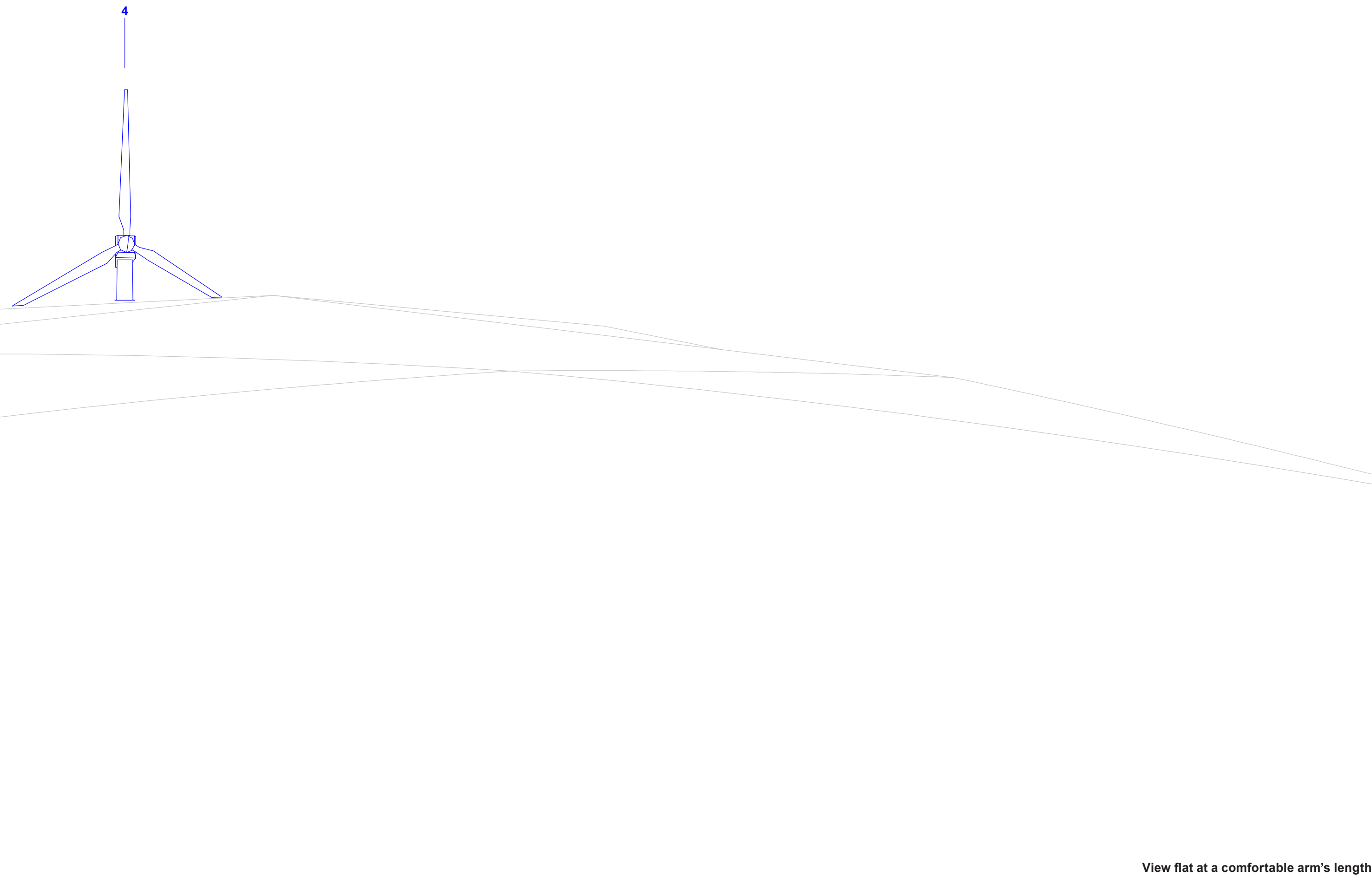

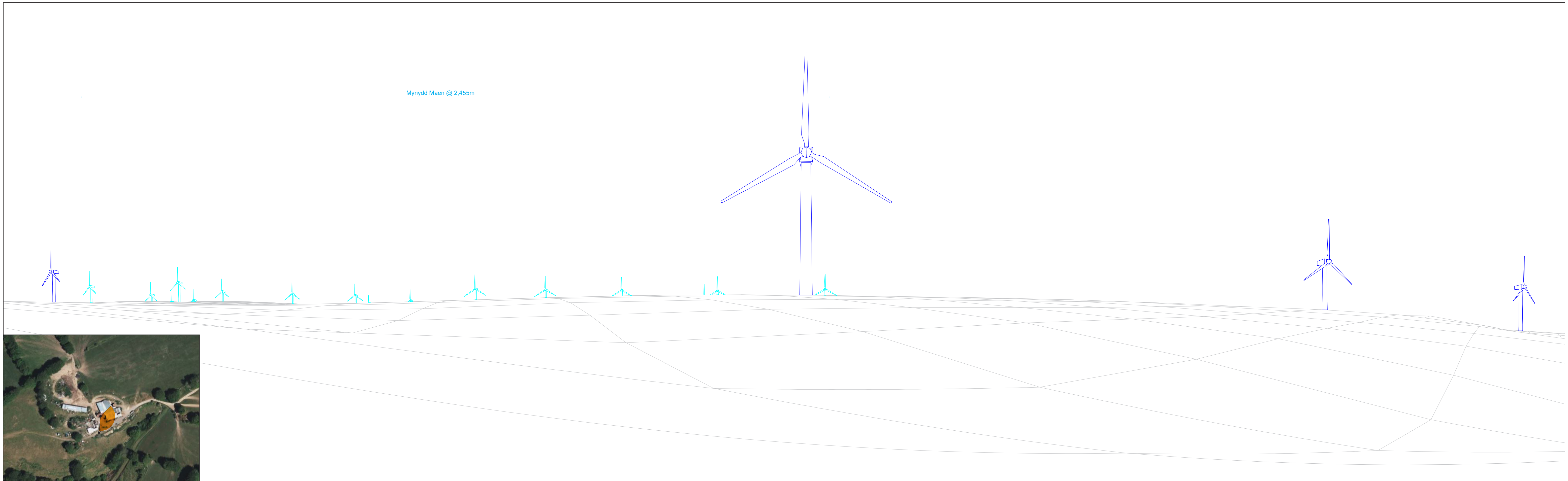
**Figure 6.18c**

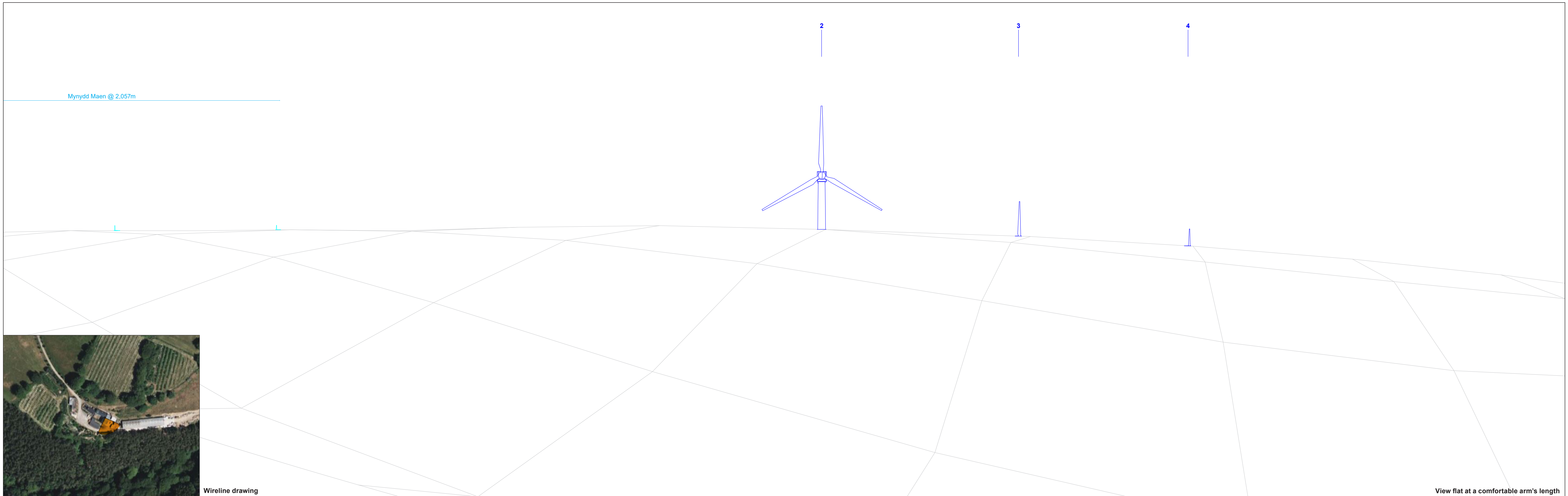
**Figure 6.18d**

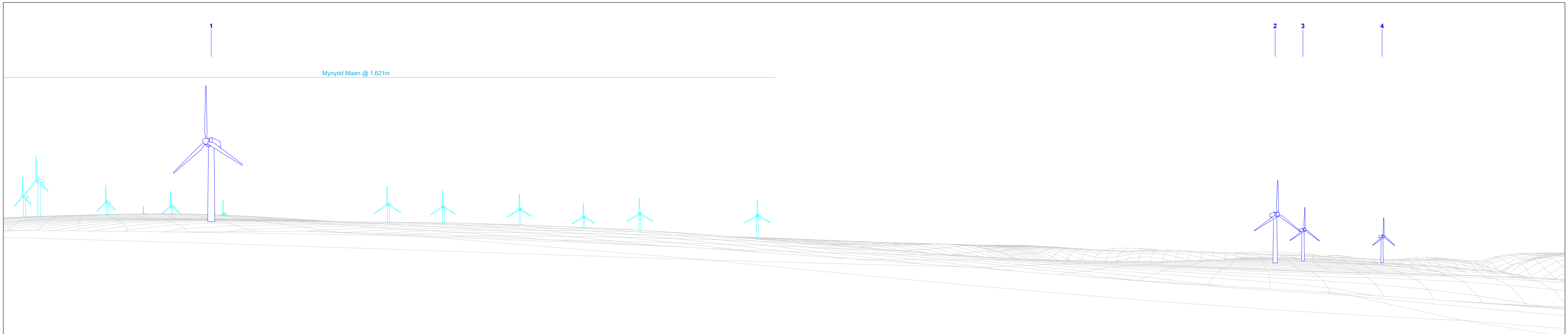

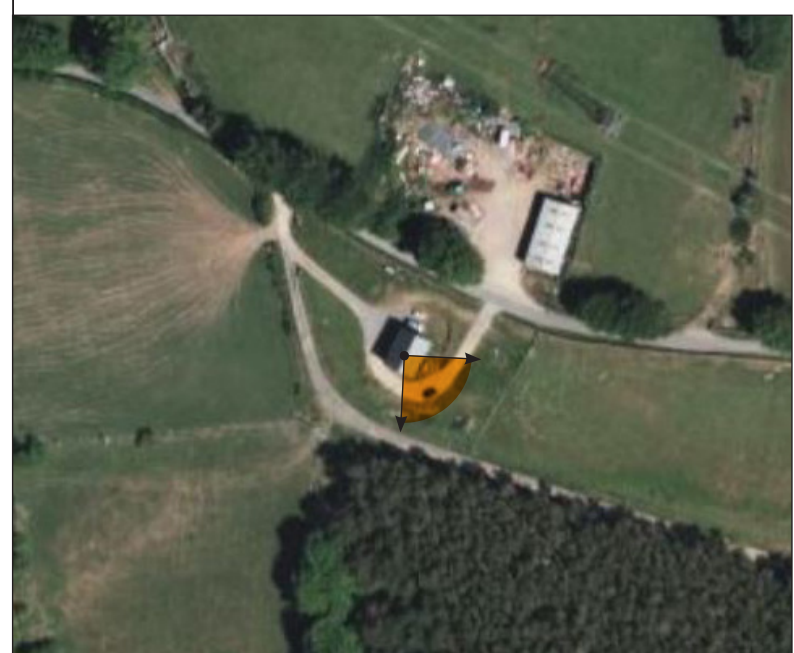
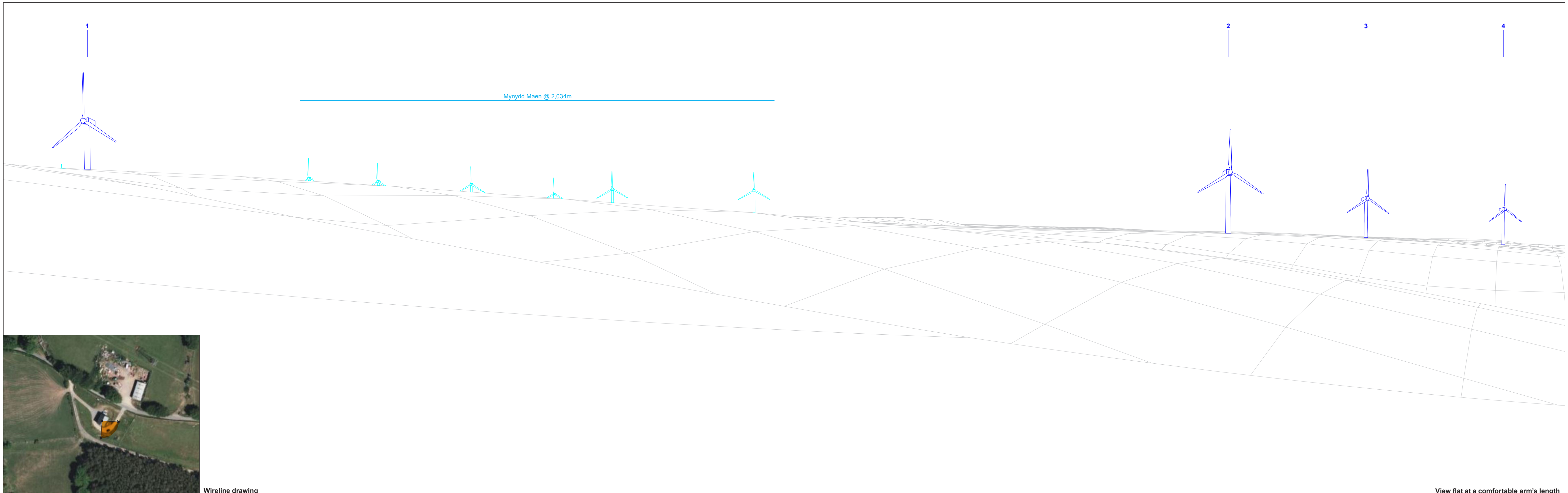
**Figure 6.18f**

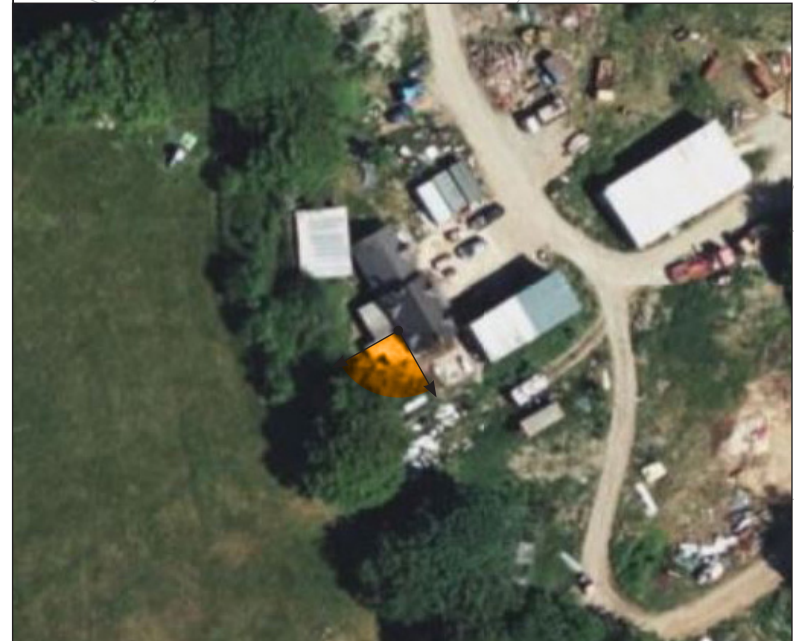
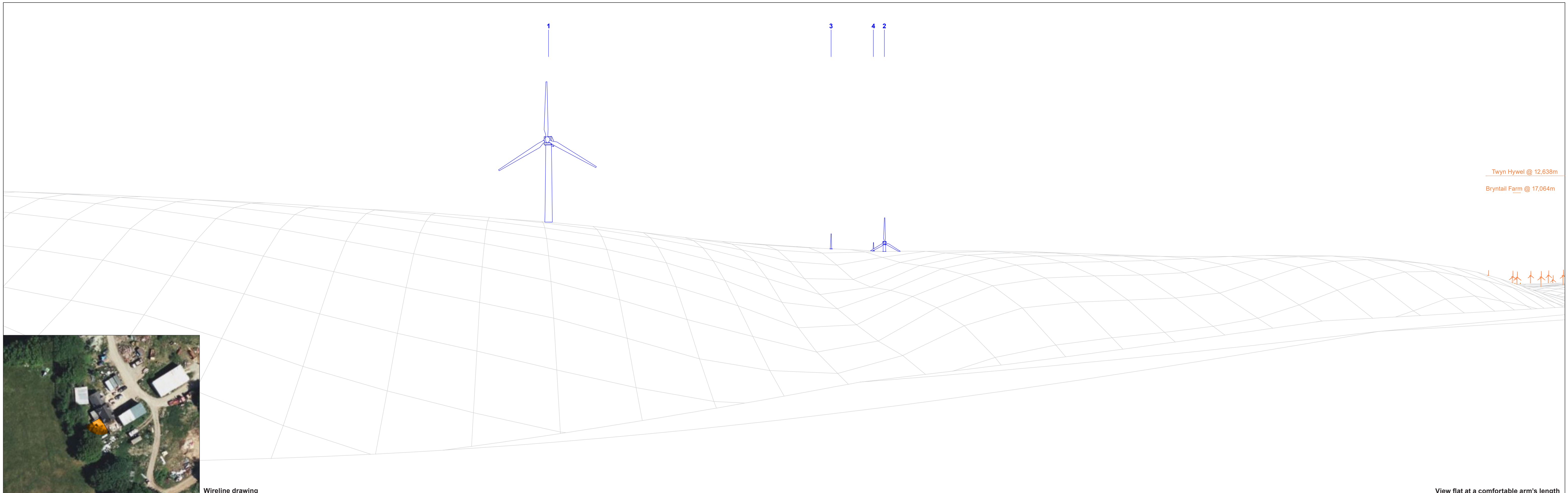
**Figure 6.18o**

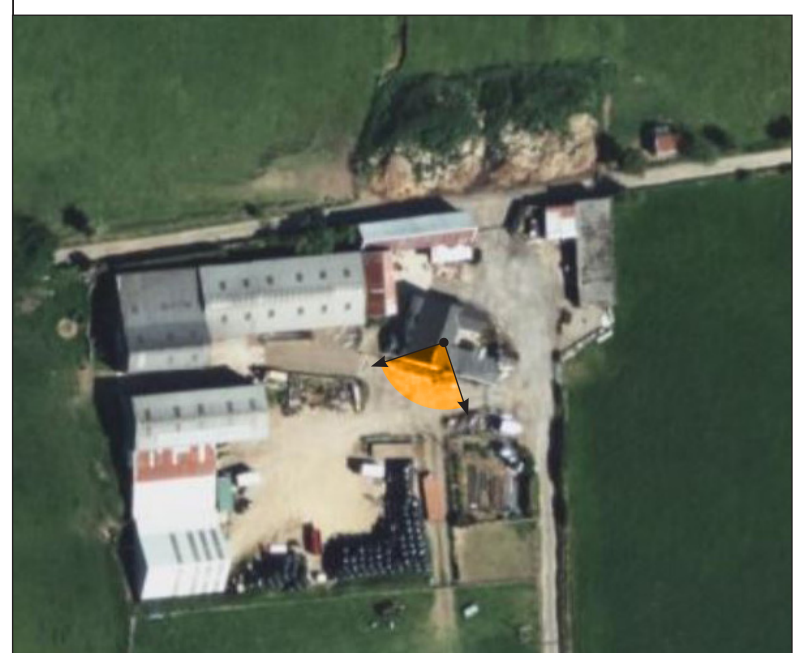
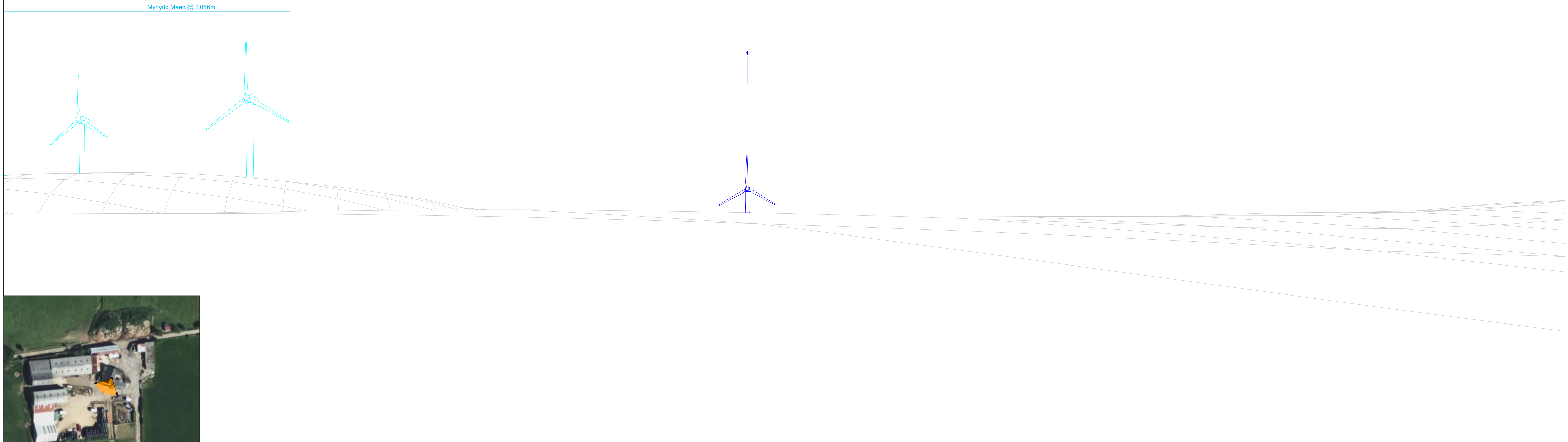
**Figure 6.18t**
