The Developments of National Significance (Procedure) (Wales) Order 2016 PUBLICITY AND CONSULTATION BEFORE APPLYING FOR PLANNING PERMISSION NOTICE UNDER ARTICLES 8 AND 9(2)

Purpose of this notice: this notice provides the opportunity to comment directly to the developer on a proposed Development of National Significance (DNS) prior to the submission of a planning application to Welsh Ministers. Planning applications for DNS will be publicised by Welsh Ministers and the relevant local planning authority; any comments provided in response to this notice will not prejudice your ability to make representations to the Welsh Ministers on any related DNS planning application. You should note that any comments submitted may be placed on the public file.

Proposed development at **Trecelyn, South Wales**. The site lies within the Caerphilly County Borough Council administrative area. The settlement of Hafodyrynys lies approximate 450m to the north west of the Northern Parcel's site boundary. The outskirts of Newbridge lie 1.5km to the west of the Central Parcel's site boundary. The outskirts of Abercarn are approximately 600m to the west from the Southern Parcel's site boundary. The Central and Southern Parcels border Abercarn Forest. The Proposed Development would be accessed via the A467 and A472 which border the Site to the west. (Grid reference: Easting, 323288 – Northing, 197011)

I give notice that **Pennant Walters Ltd** is intending to apply to the Welsh Ministers for planning permission in respect of Development of National Significance which is for a “**proposal to construct and operate a wind farm of up to four turbines (with a maximum blade tip height of 145m) and associated infrastructure including access tracks, transformer and a substation.**”

And considers that the following secondary consents are connected to the proposed application and that a decision in respect of those consents is to be made or should be made by the Welsh Ministers, or a person appointed by the Welsh Ministers for that purpose:

- **Authorisation under section 247(1) of the 1990 Act (order authorising stopping up or diversion of highway):** Consent is sought to stop up (remove sections of a Public Right of Way) and replace through the provision of a new (diverted) Public Right of Way.
- **Under section 38(1) of the Commons Act 2006 (prohibition on works without consent):** Application to allow works to take place on the Common land (works required to construct the proposed wind farm).
